

Terms and Conditions for Women In Wheels



1. Membership Eligibility and Fees

- Membership is open to individuals who meet the eligibility criteria as set by the club. All applicants must complete the membership application process and pay the applicable fees once they have been accepted.
- Membership fees are non-refundable and must be paid annually. The fee amount is subject to change and members will be notified of any changes in advance.
- The Club Membership term of a minimum of 12 months, commencing from the date of successful registration & payments
- Road Trips and events will be run by Women in Wheels and a non-refundable deposit must be paid to book your space

2. Code of Conduct

- Members are expected to conduct themselves in a manner that reflects positively on the club at all events, meetings, and in all interactions with other members and the public.

- Respect for other members, event venues, and public and private property is mandatory. Any form of harassment, discrimination, or disruptive behavior may result in immediate termination of membership.

3. Use of Vehicles

- Members must comply with all traffic laws and regulations while participating in club events or while using club vehicles.
- Members are responsible for any fines that they may occur whilst attending any events or trips.
- Any damage to vehicles or property caused by a member's negligence will be the responsibility of that member. Members may be required to reimburse the club or vehicle owners for damages.

4. Event Participation

- Members are encouraged to participate in club events. Event details will be provided in advance, and members are expected to RSVP to facilitate planning and coordination.
- Some events will require additional fees, which will be communicated beforehand.
- Women in Wheels will use photos or video footage of you and or your car for social media and website, if otherwise please let us know by emailing.

5. Safety and Liability

- Members participate in all club activities at their own risk. The club is not liable for any injuries, damages, or losses incurred during club events or as a result of club activities.
- Members are advised to carry appropriate insurance to cover personal injury and damage to property, including vehicles.

6. Termination of Membership

- Membership may be terminated by the club for violations of these terms and conditions, failure to pay dues, or actions that harm the interests of the club.
- Members may terminate their membership at any time by notifying the club in writing. No refunds of membership fees will be given.

7. Privacy Policy

- Personal information collected by the club will be used solely for the purpose of club administration and communication.

- Member information will not be shared with third parties without explicit consent, except as required by law.

8. Amendments

- These terms and conditions may be amended from time to time. Members will be notified of any changes and continued membership constitutes acceptance of the new terms.

9. Dispute Resolution

- Any disputes arising under these terms and conditions will be resolved through mediation or, if necessary, legal proceedings. All disputes must be brought in the jurisdiction where the club is based.

10. Acknowledgment

- By applying for membership, individuals acknowledge and agree to abide by these terms and conditions as set forth by Women In Wheels.

Trips & Events

- Trips and events are subject to availability and will be offered to Exclusive Members first, then online members will have the next refusal until it goes to the public. All members will be given a date to respond before going live.
- To confirm your space, a non refundable booking fee will be required, without this, your space will not be confirmed.
- All payments must be paid 4 weeks before the event, If you cancel your Event or trip before this, we would require 40% of the full amount any cancellations after will still need to pay the total cost in full.
- Women in Wheels are not responsible for any loss or damages to cars or personal belongings, this is your responsibility
- We would require you to take out the relevant insurance
- Some trips will occur costs but will be stated on advance.
